I am responding to your request of November 10, 2021, for the following information:

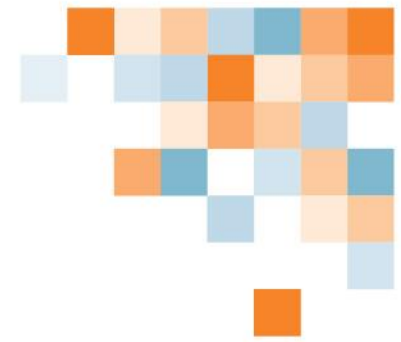

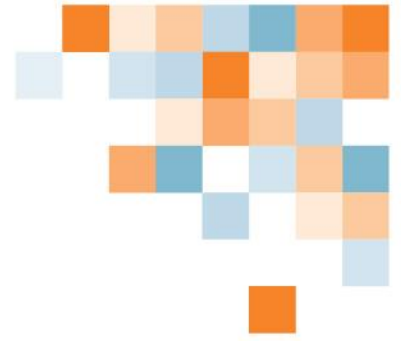
