

### TOOL AND DIE MAKER

#### **Occupation Description**

A Tool and Die Maker designs, constructs, tests and repairs production tools, cutting tools, jigs, fixtures, gauges and specialty hand tools by laying out, setting-up, machining, fitting and finishing using various metals, alloys and plastics. Tool and Die Makers produce tooling that is used to manufacture and stamp out parts, and supply tooling and dies for all manufacturing sectors.

## Pathways to Certification

In BC, an individual can become certified as a Tool and Die Maker by challenging the certification. Challenge programs are for individuals who have extensive experience working in the occupation and wish to challenge the certification.

# Prerequisites to Challenge

The prerequisite to entering the challenge pathway is a Machinist Certificate of Qualification with Red Seal Endorsement and, Tool and Die Maker trade related work experience of 2700 hours that can be verified.

# SkilledTradesBC Registration


Those who wish to challenge the Tool and Die Maker certification must complete the Tool and Die Maker Challenge Application and submit it to SkilledTradesBC. Challenge applications are assessed for proof of workplace hours and scope of experience prior to acceptance of the individual into the Challenge pathway.
